### Terms & Conditions

**1. PAYMENT:**

- A \$100 deposit is required. The balance of \_\_\_\_\_ is due 3 days before the event. You may pay by cash, check or credit card via paypal to the email /mailing address provided.
- Overtime (subject to availability) is \$150 per hour & is due immediately after services are rendered.
- All checks are made payable to DJ Joey V. LLC (No 3<sup>rd</sup> party checks accepted)
- Contract & deposit must be received within 10 days to secure DJ reservation.

**2. CANCELLATION:** If purchaser cancels DJ service, Joey V. will retain payment as liquidated damages. Purchaser may reschedule DJ service (subject to availability) for additional fee of **\$100**. In the unlikely event that Joey V. fails to provide DJ service due to Force Majeure, the Purchaser is limited to a prompt refund of all amounts paid, provided that such failure was not caused by any act or omission of the Purchaser.

**3. DJ SETUP REQUIREMENTS:**

- a) If a DJ setup area has not been specified in advance, Joey V will determine one upon arrival. Please note that the DJ equipment will not be relocated once set up. For safety reasons, Joey V will not set up in areas that may interfere with the movement of people and has the right to make changes if needed.
- b) One 6-foot table within 25 feet of a 15 amp, 120v grounded electrical outlet.
- c) A place setting with the same meal & non-alcoholic drink privileges as your guests.
- d) Access to the facility **90 minutes before the event and 45 minutes afterwards** for equipment setup & breakdown. DJ playing time may be reduced or delayed without compensation if this cannot be provided. **Please check with the establishment because multiple events are often scheduled on the same day.**
- e) If the party is outdoors, you must provide overhead shelter or a location that *completely* protects the DJ and equipment from direct sunlight and the threat of inclement weather. (Rain dates are highly recommended)

**4. DISCLAIMER:**

- a) The Purchaser shall use its best efforts to ensure the safety and security of its guests and invitees. Payment shall not be affected if Joey V. must curtail service due to the threat of injury to himself or damage to his property.
- b) In the highly unlikely event playing time is interrupted due to unforeseeable circumstances (equipment malfunction, power outage, etc...) Joey V. will either compensate for lost playing time or prorate the balance accordingly.
